Market Summary

The stock market kicked off the year on a positive note and concluded the session at a new all-time high on Thursday amid positive sentiments prevailing among the investors. The Benchmark KSE-100 index made an intra-day high and low at 176,658.38 (2,604.06 points) and 174,437.70 (383.38 points) respectively while closed at 176,355.49 by gaining 2,301.17 points. PKR in today's interbank appreciated by Rs 0.0284 against USD and closed at Rs 280.1231. The value of shares traded during the day was Rs 48.372 billion. Market capitalization stood at around Rs19.949 trillion. Overall, trading volumes for the day increased to 1399.84 million shares compared with Wednesday's tally of 954.55 million. KEL was the volume leader with 372.7 million shares, gaining Rs0.54 to close at Rs6.47. It was followed by PIBTL with 139.9 million shares, gaining Rs1.2 to close at Rs20.03 and BOP with 55.4 million shares, gaining Rs1.78 to close at Rs40.34.


