Market Summary

The stock market on Monday remained negative in majority part of the day and concluded the session in the red zone amid massive profit-taking by the investors. The Benchmark KSE-100 index made an intra-day high and low at 184,439.06 (29.39 points) and 182,303.56 (-2,106.11 points) respectively while closed at 182,384.14 by losing 2,025.53 points. PKR in today's interbank appreciated by Rs 0.0114 against USD and closed at Rs 280.0121. The value of shares traded during the day was Rs 48.173 billion. Market capitalization stood at around Rs20.589 trillion. Overall, trading volumes for the day decreased to 1026.61 million shares compared with Friday's tally of 1421.61 million. FFL was the volume leader with 65.6 million shares, gaining Rs0.16 to close at Rs22.18. It was followed by WTL with 51.3 million shares, gaining Rs0.03 to close at Rs1.83 and HASCOLNC with 47.3 million shares,gaining Rs0.18 to close at Rs20.36.




