Market Summary

The stock market on Friday remained positive throughout the day and concluded the session in the green zone amid a 75bps cut in the upcoming MPC meeting is well-aligned with macro realities. The Benchmark KSE-100 index made an intra-day high and low at 189,566.64 (1,878.48 points) and 186,637.57 (-1,050.59 points) respectively while closed at 189,166.82 by gaining 1,478.66 points. PKR in today's interbank appreciated by Rs 0.0397 against USD and closed at Rs 279.8636. The value of shares traded during the day was Rs 58.552 billion. Market capitalization stood at around Rs21.208 trillion. Overall, trading volumes for the day decreased to 875.49 million shares compared with Thursday's tally of 1066.27 million. KEL was the volume leader with 141.5 million shares, losing Rs0.36 to close at Rs6.74. It was followed by CENERGY with 53.4 million shares, losing Rs0.03 to close at Rs7.96 and HASCOLNLC with 42.1 million shares, losing Rs1.31 to close at Rs24.8.

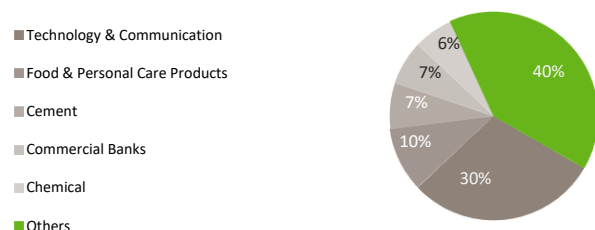

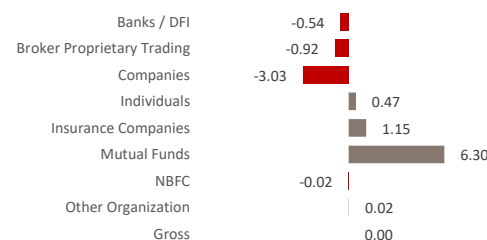

Overall Sector Turnover (%)

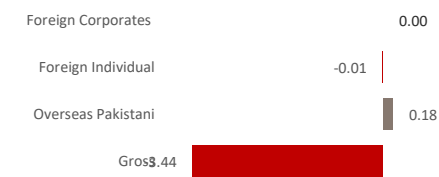

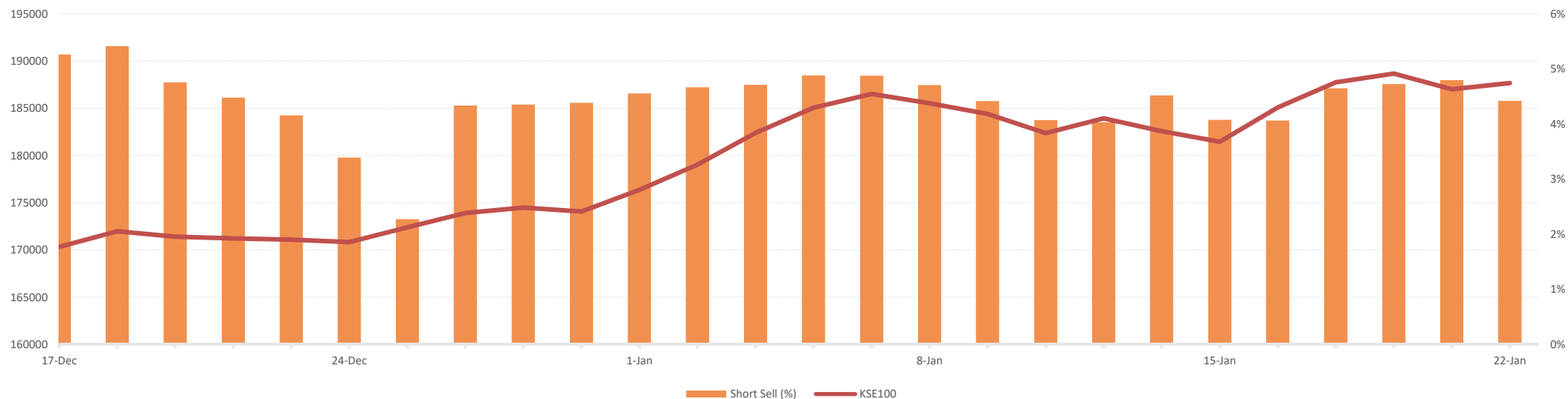
